On 09-16-22 at approximately 13:15 hours, I (Officer Rousseau) was advised there was a male subject on (CHS) campus (201 S Hurst, Burleson, Johnson County, Texas) that did not appear to be a CHS student. ██████████ Principal ██████████ stated that he was talking to the male subject by his office. I met with the two and walked with them to an office.

While walking the male to the office, a female student told me that the male did not go to school here and that his name was David. The male was later identified as David Stanford ██████████ When asked, Stanford advised that he had graduated from home school and wanted to know what public schools were like. He stated that he coordinated with three CHS students to be let in the school. A Criminal trespass was placed on Stanford for 201 S Hurst and a citation will be mailed to Stanford for Criminal Trespass on school campus.

No charges will be filled for the three students involved in allowing Stanford in the building. They will receive disciplinary actions through the school.
